In 2019, ISEA Foundation agreed on the usage of the Blockchain currency, MobiDollar and 'the Seven Key Elements of Survival Human Rights' (<https://gbfccom.com/survival-human-right/>) in U.N. Geneva Conference, where some Governors, representatives of IGOs, and NGOs from each country participated.

Also, in 2020, the documents titled 'Survival Human Rights Protection and COVID-19 care fund by Blockchain Cryptocurrency of MobiDollar' was approved as a statement of the U.N. General Assembly
